# FP2030 Commitment

GHANA'S FAMILY PLANNING VISION FOR 2030: All persons of reproductive age in Ghana have equitable and timely access to quality family planning information, commodities, and services.





## 1. Ensure the full implementation of the roll-out of the plan of FP under the National Health Insurance Benefit Package (NHIS)

- Develop FP on NHIS, a costed nationwide roll-out plan
- Develop and implement a dissemination strategy for the roll out plan
- Implement a National FP on NHIS technical working group
- Implement FP on NHIS roll-out plan across the country
- Annual review of FP on NHIS roll-out



### 2. Increase modern contraceptive prevalence rate (mCPR) among currently married women or women in union

- Expand method choice through increased commodity availability and service provider capacity
- Increase private sector capacity to provide modern contraceptives
- Increase the availability of FP services in the immediate postpartum and post-abortion periods
- Expand self-care interventions for modern contraceptives
- Improve family planning data management
- Explore diverse service delivery to reach all women
- Leverage Ghana's ongoing cost-saving strategy of encouraging on the job training



### **3.** Reduce unmet need for contraception among sexually active adolescents

- Collaborate with government and non-governmental agencies
- Advance interagency collaboration to promote accessible FP services for youth
- Identify champions/activists/advocates to garner public support
- Mobilize and build a critical mass of FP advocates
- · Strengthen partnerships with community institutions to promote FP use among adolescents
- Develop and package FP commodities/contraceptive information in user friendly formats and diverse languages for young people; Promote private public partnerships
- Enhance public health engagements with communities
- Strengthen media engagements

#### 4. Ensure implementation of FP behavior change promotion

- Carry out local research and adopt findings
- Expand FP demand generation activities
- Establish systems of coordination among the private sector, CSOs, and the public sector
- Develop targeted community-based acceptable information education communication materials
  - Incorporate human rights-based principles in the training of all cadres of service providers

## FINANCIAL OBJECTIVE: INCREASE GOVERNMENT FINANCIAL COMMITMENT TO PROCUREMENT OF FP COMMODITIES

The Government of Ghana will increase the government financial commitment for the procurement of 20% of Ghana's FP commodities needs by 2030.

#### They will also:

- Fulfill compact agreement of donors regarding contribution to FP procurement
- Allocate funding for the purchase of FP commodity
- Advocate for domestic resource mobilization
- Actual expenditure on the FP budget line beyond FP budget allocation
- Budget monitoring framework to track funds for FP

# **Approach to Accountability**

#### Ghana's approach to accountability will:

- Develop a specific FP scorecard to track commitments based on existing platforms to strengthen existing accountability mechanisms that are integrated in the Global Financing Facility costed prioritized operational plan and the UHC Road Map and National Health Policy.
- Bring together stakeholders at existing convenings to monitor progress at the national and subnational levels.

### They will use existing platforms, including:

- Track 20 Family Planning Estimation Tool
- MSI Impact Calculator
- Ghana Demographic Health Survey
  (DHS) and Maternal Health Survey
- PMA2020
- Reproductive, Maternal, Newborn, Child and Adolescent and Nutrition Scorecard


### COMMITMENT PRINCIPLES:
