## **Position Overview**

FP2030 Asia and the Pacific hub is based in Kuala Lumpur, Malaysia hosted by IPPF ESEAOR office.

FP2030 seeks to commission a short-term consultancy to support the planning, coordination, and co-facilitation of **a SMART advocacy workshop in Lao PDR**, in collaboration with national focal points, development partners, and key stakeholders.

### Scope of Work

The consultant will work closely with the Senior Technical Lead – Advocacy, Accountability and Partnerships to:

- Provide technical input into the development of the workshop agenda, in consultation with FP2030 and the core working group of national stakeholders proposed by the focal points.
- Conduct a brief landscape assessment to identify the main advocacy priorities
- Co-facilitate the SMART advocacy workshop alongside Senior Technical Lead Advocacy, Accountability and Partnerships, supporting session delivery, group exercises, and discussions.
- Support the adaptation of workshop content and materials to reflect national priorities, policies, and context for family planning and health advocacy.
- Participate in preparatory meetings and consultations with the FP2030, national focal points, development partners, and key advocacy actors.
- Assist in documenting key workshop outcomes, action points, and recommendations for follow-up advocacy actions.
- Advise on local logistics, venue selection, and participant engagement where appropriate, in coordination with the organizing team.

## **Selection Criteria**

- Relevant academic background in sexual and reproductive health and rights (SHRH), family planning, public health, international development or related fields.
- Demonstrated experience in advocacy engagements, workshop facilitation and capacity building– experience in SMART advocacy workshops is an advantage
- Strong analytical, facilitation and communication skills.
- Good understanding of policy processes, advocacy opportunities, and challenges related to family planning and SRHR in Lao PDR.
- Excellent writing, reporting and presentation skills.



- Ability to work independently and deliver high-quality outputs within the agreed timeline and budget.
- Must be a Lao PDR national and/or based in Lao PDR. (Applicants with strong experience in conducting SMART Advocacy workshops in Asia, who are based in Asia will be considered as well.)
